Our office will be closed from December 24th until January 1, 2009. We will

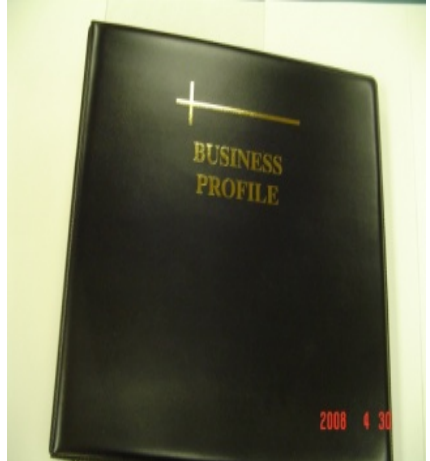
resume operations with a skeleton crew on January 2, 2009 and resume with full staff in the office on January 5, 2009.

We are also selling the Business Profile Binder for owners to maintain and keep all of their important regulatory documents. This is for a nominal fee.





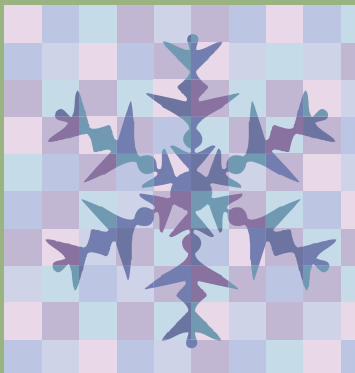

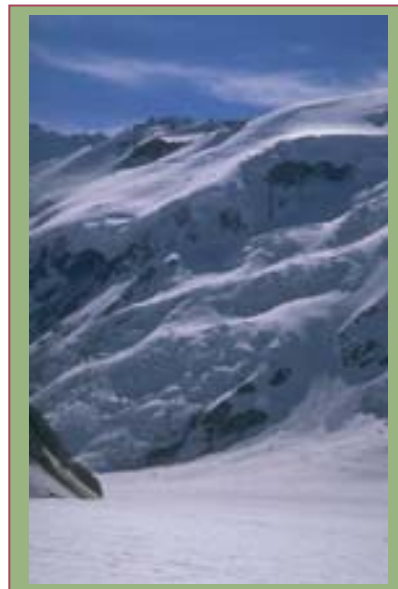
