resume operations with a skeleton crew on January 2, 2018 and resume with full staff in the office on January 5, 2018.

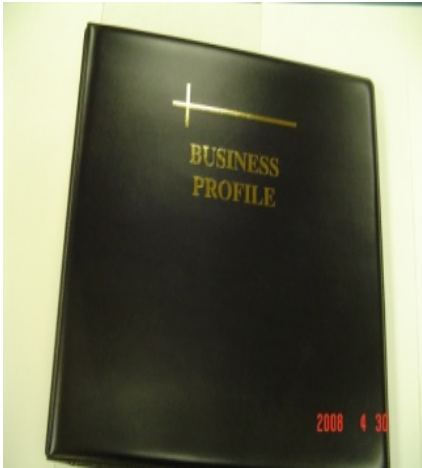
We are really looking forward to working with all of you in 2017 and encourage you to book your consulting visits now for January. It seems like the time goes so fast and 2018 will be here before we know it!

We are also selling the Business Profile Binder for owners to maintain and keep all of their important regulatory documents. Cost \$89.95 includes shipping and handling.





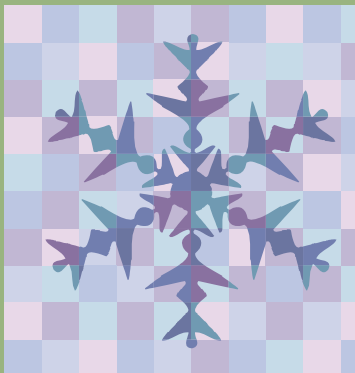

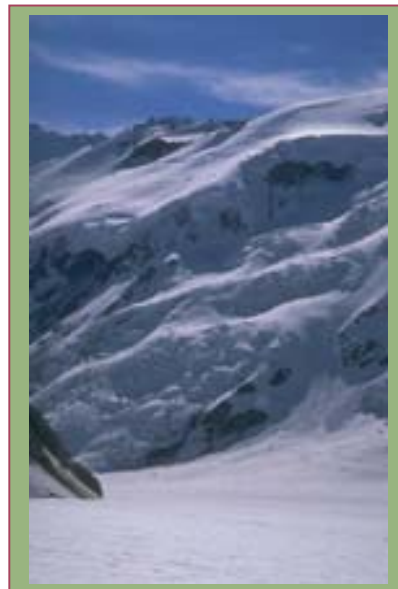
